## ELIGIBILITY

The 2016 Artists of the Upstate Juried Exhibition is open to artists 18+ living within a 35-mile radius of Greenville, SC. Entries must be original works of art that have been completed within the last three years. Entries in all media categories will be accepted but should not exceed 40 pounds in weight or 60 inches in height or width. The exhibition is not judged in media categories.

All original works must be received ready for exhibition with appropriate hardware for wall hanging in place. Works on paper must be framed and under glass or plexiglass. We are unable to accept work that requires special instructions or installation by the artist. Works not adequately prepared for display will be withdrawn from the exhibition. The 2016 Artists of the Upstate Juror will serve as the final authority on eligibility.

## ENTRY PROCEDURE

A non-refundable fee of \$25 enables each artist to enter up to two works. Please submit one digital image per work to be juried. Complete the entry form portion of this prospectus and return along with the required entry fee, CD with images of work submitted, and reference sheet of images on CD on or before Friday, April 8, 2016. Please also include a self-addressed stamped envelope for mailing the notification letter. If you wish your entry CD returned, the envelope must be of adequate size and bear sufficient postage to accommodate return.

## ENTRY FORMAT

All entries will be judged from digital files. Entries must be submitted in digital format burned to CD and should conform to the guidelines noted below. Slides, DVDs and photographic prints will not be accepted.

- Image files must be submitted on a CD along with a hard copy entry form; no email entries will be accepted.
- Each image file must be in .jpg format and should not exceed 5 MB in size.
- Name each file as follows: EntryNumber.Title, eg., 01. Apples, 02. Pears
- Please be sure that all images are correctly oriented.
- Include a reference sheet with thumbnail pictures of the images on your CD. Beside each thumbnail, note the artist's name, title, and entry number as indicated on the entry form.

## AWARDS

Four cash prizes will be distributed including: Best in Show (\$1,000), 2nd Place (\$750), 3rd Place (\$500), and Award of Excellence (\$250). The 2016 Artists of the Upstate Best in Show award winner will be invited to exhibit work as the Featured Guest Artist at the Art Cellar during the Artisphere 2017 festival.
